Starke Managed Pricing Program with Wellington.....

- Enrollment may only be during the enrollment period listed for each contract
- Final pricing on the contract is available only on the end date of the pricing period
- All pricing trades will be done by the Co-op's team of professionals
- The team may at any given time use any of the tools available in the marketplace to come to a final price on the end of pricing period date
 - This may include the use of futures, options and spreads
 - All trading will be in the commodity being priced
 - Positions will be available at any time through the Co-op grain staff
- Contracts must be in 5000-bushel increments for corn and 2500-bushel increments for soybean and recommend it should not constitute more than 25% of total production
- At the end of the pricing period, the customer will receive a Hedge to Arrive contract for the futures month listed in the contract
- Further pricing action will be as a Hedge to Arrive, the customer will need to set basis and delivery for the contract. This may be done before or after the contract is final priced.
- A fee of \$.08 will be charged to the final price of the contract
- All other rules for contracts with the Co-op will apply to this as well
- Customer may chose a flex delivery option at any time for an additional \$.05 fee
